## Interpretation:

Molecular genetic analysis was performed for a specific mutation reported to be associated with Chondrodystrophy with Intervertebral Disc Disease Risk Factor (CDDY with IVDD) in dogs. We identified two normal copies of the DNA sequences in the *CFA12 FGF4* gene tested. Thus, this dog is not at an increased risk for Chondrodystrophy with Intervertebral Disc Disease Risk Factor (CDDY with IVDD).

## **Recommendations:**

No mutations were identified. Thus, this dog is not at an increased risk for the disease caused by or associated with the mutation tested. Because this dog is "clear" of this mutation, this dog will only pass the normal gene on to its offspring. Normal results do not exclude inherited mutations not tested in this gene or other genes that may cause medical problems or may be passed on to offspring.
